  time the announcement is sent in which the directors may record their
  vote; and
- The corporation must make a physical record of the electronic mail announcement and the vote of each director to be presented to the directors at the next board meeting or filed in the corporate minute book.

Any matter put forth for approval via electronic mail must be approved by a majority vote of directors, unless the corporation's articles of corporation or other sections of the Bylaws require a greater number of votes. Any action taken by electronic mail will be effective as of the deadline set forth in the electronic announcement, and a director may change the director's vote at any time before the deadline set forth in the electronic announcement.

In order for the Board to take action without a meeting pursuant to this Section 5.16, the Corporation must have a record of an electronic mail address for each director."

Article 5, Section 5.2.3 is hereby added to read in its entirety as follows:

"Before joining the Board, any director elected or appointed to the Board pursuant to these Bylaws shall consent to a background check, the type and scope of such background check shall be chosen by the Executive Director at the direction of the President and the Executive Committee."

Except as expressly set forth herein, the terms and conditions set forth in the Amended and Restated Bylaws shall remain in full force and effect.
